#### 1.3 - Curriculum Enrichment

A strong value-based holistic development of students is achieved by the successful integration of cross-cutting problems relating to gender, the environment and sustainability, human values, and professional ethics in the Wilson College curriculum.

#### 1. Gender Sensitivity:

Courses on gender are an essential part of many curricula offered by the University of Mumbai. Learners are made aware of the need for gender equity and inspired to strive towards it from a multicultural standpoint. The learners are familiarized with basic concepts of sex, gender and going beyond the gender binary debate. Lerners are introduced to various Feminist Perspectives and are exposed to the historical account of women's struggles. The curriculum acquaints the learners to new and emerging issues such as Indian feminist landscape, newer methods of protest and resistance, feminization of Workforce, issues faced by home-based women workers, role of self-help groups and microfinance in women empowerment etc.

#### 2. Environment and Sustainability:

Institute offers courses which educate the learner in Bioremediation, Pollution control, Application of enzymes in environmental sustainability, Biosafety, biofuels, biofertilizer, biopesticide, vermicomposting, bioleaching, biosensors and Biochips, Recovery and purification, effluent treatment.

Courses also familiarizes students with important environmental concepts like Carbon footprint, Sustainable development, Ecofeminism and Feminist Environmentalism.

#### 3. Human Values and Professional Ethics:

Courses introduce human values like Inclusive Growth, Sustainable Development, Zero Hunger, Clean Water and Sanitation, Affordable Clean Energy, Reduce Inequalities, Justice and Strong Institutions.

2.3.1 - Student-centric methods such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences:

Field visits and outreach activity

The Department of Political Science had a field visit in the Konkan region of Maharashtra to have an insight of the 'Rural Local Self-government'.

Hands on experience

The department of History provides opportunities for internship and volunteering/ being a docent which provides practical experiences. The department of Microbiology students undertook internship in various diagnostics clinics, hospitals and Dairy. Microbiology students conducted practicals to create awareness among school students regarding personnel hygiene, impact of microbes.

The Zoology Department conducts "Fish- o-Fest", a fest where students prepare dishes of fish or Prawns and delicacies are

judged. The Department of Botany extends the food processing practicals into professional display and organoleptic evaluation.

### 2.3.2 - Teachers use ICT-enabled tools including online resources for effective teaching and learning

Teaching and learning is more effective when conversational teaching with chalk and board is augmented with ICT-enabled tools. Teachers used powerpoint presentations and incorporated educational videos available on digital media like YouTube for better understanding of the subjects, particularly in science stream. Google Classrooms were created by teachers for the ease of sharing of the study material, submission and assessment of assignments. Lot of study material was created by the teachers in the form of handouts, Google slides, recorded lecture videos etc were made available to the students online. Virtual lab simulations were used by some teachers for the practical knowledge of the science subjects. Digital platforms like Google meet and Zoom were used for conducting lectures/sessions which provided an enhanced learning experience to the students in the comfort of their home. Evaluation is an integral part of the teaching learning process for which along with paper pen tests, Google forms were used for conducting quizzes. Teachers used online portals like Quizizz for conducting multiplayer classroom quizzes and marking teaching more interesting and exciting.

Observations and objectives of AG are communicated through their report whenever the audit takes place, and those are examined by the treasurer, registrar, internal auditor and any other member nominated by the principal.
